# **E-NOTICES**

Starting in April or May, if you have home banking or have an Email address on file, the Credit Union will begin sending your notices directly to your Email address rather than mailing a paper copy of the notice through the United States Post Office Department.

If you wish to continue to get a paper copy mailed through the Post Office, please contact the Credit Union. If the Email address we have on file for you isn't a valid Email address, the notice will get returned and we will print and mail your notice to the address on your account.

# HOME BANKING
