# **Interesting Facts on Trust Accounts:**

- 1) The IRS allows you to use your social security number on your Trust Account.
- 2) The IRS does not allow a financial institution to pay interest on a deceased person's social security number.

So if the person whose social security number is used on a Trust Account dies, a financial institution cannot pay interest on the Trust Account. It is the credit union's recommendation that you get a separate identification number for the Trust. Once someone dies, there are so many things to deal with, why add one more (like getting the number changed)?

For security reasons and to help prevent fraud, please notify the credit union if you are traveling and wish to use your ATM/Debit or credit card.



# INSURANCE AND FRAUD PROTECTION

# MasterCard & VISA LIABILITY CHANGES VISA MasterCard





# The following liability revisions are for Visa and beginning October 17, 2014 for MasterCard:

- The zero liability rule will now apply to all transactions conducted with a MasterCard or Visa brand card. Previously, zero liability only applied to point-of-sale transactions.
- A cardholder will not be liable for any unauthorized transaction, as long as:
  - 1) the cardholder has exercised reasonable care in safeguarding the card from risk of loss or theft, and
  - 2) upon becoming aware, promptly reporting the loss or theft to the issuer.

Previously, if the above conditions were not met your liability was limited to a maximum of \$50 for transactions conducted by the unauthorized use prior to your notification to us. This maximum of \$50 has been removed.
